## CONSTITUTION REVIEW

Council are meeting on 24 February 2013 at 1pm in the Office to review an updated Constitution, and following agreements a Special Meeting of Members will likely be called to endorse any proposed changes.

## FCCWA RELEVANCE AND VALID RECORDS

Council has agreed to ask all our members to advise us - at least annually - what cats they own or lease and whether they are breeding cats or sterilized cats/kittens. This is so we may bring our data base records up to date. **Such information will be kept strictly confidential.** The DB contains every single cat and kitten registered by our breeders since it was started up. However, many cats will have passed away, been sterilized, maybe given away as pets etc, and should be recorded as such. We need also to have some idea of the overall number and status of our members' cats - so we may quote valid statistics, and advise government in general terms. Effectively if required we need to be able to show the authorities what and who we represent within the cat fancy. Please talk to a Council member if you have any concerns. A form will be distributed to all our members in the near future. Your cooperation would be appreciated.

## PERSONAL MEMBERSHIP RENEWALS - APPLICATIONS

A reminder that members renewing or joining need to personally complete the paperwork, and provide all contact details. A lot of our communication is now via email so it is important to let us have your email address. We will need also a phone number and a street address. If you prefer your mail via your own Post Office Box, just let us know and provide that information as well as your street address. **Please note that members' contact details are kept confidential,** although email lists are provided to FCCWA Show Secretaries only for the sending out of schedules. Thank you.

## SHOW RULES

Are being reviewed - Council is looking at updates which should be ratified at its February meeting ready for the 2013 show season. Don't panic show secretaries - no fundamental changes, but we need to bring the wording in line with, for example, the Cat of the Year procedures brought in for 2012. **6. MOTIONS ON NOTICE / SPECIAL RESOLUTION TO CHANGE THE FCCWA CONSTITUTION**

6.1 Composition of Governing Council

MOVED: Carole Galli, Seconded Linda Horton that the Constitution be amended as follows:

Part A

Clause 17 (1)(e) be amended, effective for the 2014 elections, to read: six(6) other persons.

Clause 22(5) be amended, effective 2014, to read: At a Governing Council meeting six (6) Members will constitute a Quorum

and Part B

Clause 17(1)(e) be amended, effective for the 2015 elections, to read: four(4) other persons.

Clause 22(5) be amended, effective 2015, to read: At a Governing Council meeting five (5) Members will constitute a Quorum.

Rationale The number of members of FCCWA has reduced over time and the current requirement for 12 represents 12% of members. This has resulted in casual vacancies occurring over several years. By making a transitional change over the next two years, Council will better reflect our membership.

It was RECOMMENDED to Council that Dr Don Nickels be appointed a Life Member of the FCCWA following over 25 years of outstanding service to the Association as our Consultant Veterinarian (Proposed by Carole Galli, Seconded by Margaret Bush)

**7.2 2011 Cat Bill**

Linda Horton gave a verbal report on the latest situation. Linda continues to be our representative and liaise with the Government Departments. SPECIAL THANKS were extended to Linda for heading the drive to get a fair deal and recognition for members of WA registration bodies, both for show enthusiasts and breeders.

**7.3 Affiliated Clubs - in recession / dormant**

It was NOTED that the RARE Club has advised Council that it has gone into recession. It was NOTED also that other FCC Affiliated clubs were having financial and resource difficulties. The matter of club affiliation when inactive or in recession was referred to Council.

**7.4 Cat Of The Year Winners For 2012**

It was NOTED that Maureen Gentles had especially asked for the records to be left with her to do calculations. Sadly Maureen was not able to complete the task and efforts were now being made to retrieve the show schedules and judging slips. Council members would ensure that the calculations were done, if necessary from duplicate records, and would arrange for all the trophies and so on. The Trophies will be presented at a lunch time event on Sunday 20 January 2013.

# President's Report 2012

Welcome all to the AGM for 2012

2012 has been a year of consolidation for FCCWA after the turmoil of last year. The year started with the loss of Harry Bush, along term supporter of FCCWA and sadly ended with the loss of Maureen Gentles, another loyal FCCWA member. Another supporter, Dr Don Nickels has been very ill and retired from the Experimental Breed Committee, which he has been a member of for many years. We thank Dr Nickels for his ongoing advice and support to the Committee and the breeders involved in programs. Personally I can say that his knowledge and advice of genetics has been invaluable to me as a breeder. Governing Council sent a certificate of appreciation to Dr Nickels in September acknowledging his contribution to FCCWA. I would certainly support Dr Nickels being awarded Life Membership to FCCWA.

On a brighter note there have been some achievements this year that must be acknowledged

- Linda Horton has chaired a tripartite group for FCCWA, COAWA and ANCATS to lobby Government on the Cat Bill 2011. There has been moderate success and the group will continue next year to influence policy makers to protect the interests of our breeders
- Three of our judges, Paul Raftopolous, Lee-Anne Pitman Pryde and Jane Horstman have extended their judges licences
- Pamela Lanigan completed her training as a Group Three Judge
- We have approved Kirsty Connell to commence training in Group One in 2013
- A new stylish website has been launched and will be expanded to include a Kittens Available Page. This page will list breeders who have registered kittens in the prior 3 months and who have paid to be in the breeders' directory. We hope this will assist our breeders with kitten sales
- A Micro chipping session was held for members to have their cats chipped at a very reduced cost
- Financially we are more stable than last year, however income from registrations has not increased
- All work has been done by a very few dedicated workers on a voluntary basis

To give you a snapshot of our association I can advise that

- 769 new kittens were registered plus approx. 20 cats re registered
- Our membership was just over 100 for the last year and currently 72 people have renewed for 2013
- 41 Breeders registered kittens in 2012
- Our top 5 breeds registered are Burmese (235), Ragdolls (91), Persians/ Exotic (76), Burmilla (63) and Siamese/Oriental (62)

In 2013 we need to continue to set and maintain our standards as set out under the Code of Conduct. This is vital so that we can demonstrate that we are being responsible and to maintain our status under the Cat Bill 2011. Breeders will need to register their kittens and maintain ethical breeding practices to be protected by membership to FCCWA as a prescribed organisation. Breeders should be reassured that FCCWA will maintain confidential records and will only confirm membership. Any other information can only be released with the approval of members. As a prescribed organisation under the Act we are expected to maintain accurate records of our members, including correct contact details.

Finally can I thank all of the dedicated team who have supported me this year? Specifically I would like to thank Diana Nixon who has worked in the Office every week. Her knowledge has been invaluable and I hope we can convince her to stay on next year. Sue Game, Linda Horton and Margaret Bush have all worked tirelessly and I thank them on behalf of our members. Please give them a round of applause to show our appreciation. Members of Governing Council have also willingly given their time to assist with fundraising, shows and special events, thank you.

We do need members to pitch in and help keep our association viable. We also need to rejuvenate our membership list and try to offer young exhibitors and breeders opportunities that encourage them to participate and learn.

I wish all members a happy festive season and hope that 2013 is exciting and prosperous!

## Secretary's Report 2012

Sadly this year we have lost two of our long time members - Harry Bush and Maureen Gentles. Tributes have and will continue to be paid to these two people, suffice to say they will be missed.

On the Administration and Membership side, things have been positive this year. We have a good team on Governing Council, we have met regularly and meetings have run smoothly under the Chairmanship of Carole Galli who provides a business-like forum where we can discuss issues freely and make sound decisions. We have a number of sub-committees (Fund Raising, Show Rules and Constitution Review amongst others) who report regularly to Council, and thus we keep things moving.

At the end of 2012 we had some 94 members - which include life members, single, double and associate. Our list of paid up members for 2013 as at today is 72. Please remind your friends and colleagues to renew their memberships.

Although we had ten clubs on the books at the end of 2012, we have received advice that the RARE club is going into recession, and three other clubs are not really functioning. However, the other clubs have put on shows for us in 2012, and we have a new club - British Shorthair - and they will be permitted to hold a championship show in 2013. The FCCWA Governing Council itself hosted one show during the year. Thanks especially to Greg Cox for his assistance with setting up and shifting cages for all the clubs and for the FCCWA show. We are encouraging members to purchase their own exhibition cages, so it will be much, much easier on the organizers to set up a show.

Judge training had progressed well during the year with three judges extending their qualifications: Jane Horstman, Paul Raftopoulos and Lee-anne Pitman-Pryde, and one new judge: Pamela Lanigan. Plus we welcome Kirsty Connell as a new trainee in Group 1. The ACF has adopted a 'competency based' style of judge training which, without lessening the standard of training and strict protocols, allows us to mould assignments and tests to suit individuals, use modern technology, and to fit in with the limited number of shows and exhibits here in WA.

Linda Horton has done a great job with our *Cat Call* - which has gone digital. We will continue to send the magazine and important notices to those members without computers (such notices as required by our Constitution), but I am sure everyone will appreciate that email news and exchanges are the modern, cost saving and timely way to communicate. We currently have some 70 member email addresses and would encourage everyone to let us have up to date information on their contacts, including emails.

We have a new look web site - <http://www.fcc-wa.com/> - went live at the end of November 2012. We intend to keep this updated regularly, as well as post notices, news, information, show results, show schedules, and of course *Cat Call*. Many thanks must go to Pamela Lanigan for keeping our other site up and running in the meantime.

In the office, Carole Galli and Margaret Bush are sharing the Registrars job (with Penny Kelly as a reserve). I give special mention and thanks to Diana Nixon, who has been keeping the office going - doing the titles and membership records, fielding the majority of calls, and being her helpful, friendly self when our members phone with concerns. We are all volunteers, giving our time and expertise to the FCCWA

Importantly, Council is keeping abreast of the progress of the Cat Bill 2011, and has been proactive in modifying our breeding regulations in line with intended legislation. Linda Horton has been our very busy liaison officer with the Ministry for Local Government and the Politicians. Linda will give us an update this evening.

Our Treasurer/Registrar, Margaret Bush, will be reporting on our income including registrations, transfers etc, but I believe that we have maintained our status quo in this regard.

I will leave it to our President/Chairman Carole Galli to extend all the formal thank-yous to the Council Members, Office Bearers, and others who have contributed to this successful year for FCCWA, but I would like to say that it has been a pleasure to be your Secretary this year.

DOCEP has developed model rules which may impact the constitution. In addition, the introduction of a website, the use of emails as a communication tool and the increase in popularity of owner-cages (for example) means that some of our rules need adjusting.

In addition, in our fast moving electronic world, some of the deadlines that were set in the past are no longer necessary or practical.

Governing Council are currently reviewing our rules and you will be advised of any changes. Any amendments to the constitution must be done at an AGM or at a Special Meeting, so you will have the opportunity to vote on changes.

# FCCWA Code of Conduct for all members

## 1 Purpose of the Code of Conduct

- 1.1 To provide members of the Feline Control Council WA (Inc) with a framework for appropriate conduct. This includes behaviour towards other FCCWA members, judges, general community members and cats.
- 1.2 The core principles that underpin the organisation must be the welfare of all cats that fall within the scope of FCCWA and the protection of the integrity of FCCWA pedigrees
- 1.3 Incorporated in this Code of Conduct is a Code of Ethics for all members who wish to be recognised as Registered Breeders. All FCCWA Registered breeders must agree to uphold and respect this Code of Ethics in their actions and dealings within the Cat Fancy.

## 2 General Principles of Conduct

General principles to guide the behaviour of FCCWA members include that all members must:

- a) Act with reasonable care and diligence
- b) Act with honesty and integrity
- c) Act lawfully
- d) Avoid damage to the reputation of the FCCWA (Inc)
- e) Treat others with respect and fairness.
- f) Abide by any rules, regulations or guidelines as determined by FCCWA (Inc) including Breeding, Showing, membership of Governing Council or any other activity. Such regulations will be available on the FCCWA website.
- g) Comply with the WA Cat Act (2011) and any other relevant legislation.

## 3 Rules of Conduct

All members of the Feline Control Council of Western Australia (Inc) will abide by the following:

### 3.1 They WILL:

- a) Act appropriately and treat people with respect, never being derogatory in their speech or manner
- b) Act in the best interests of the Association (FCCWA) and not seek to gain any advantage for themselves, their family or friends
- c) Act in a way that is fair and unbiased
- d) Seek to resolve any conflict or dispute amicably in the best interests of the FCCWA
- e) Declare or avoid (where practical) any conflict of interest whereby an individual may gain an unfair advantage at the expense of other FCCWA members, show participants or the organisation
- f) Desex all non-pedigree cats and any pedigree cat that they intend to keep that is not part of a breeding program
- g) Care properly for all cats that they own or are responsible for, providing proper housing, food and veterinary care, and not permit them to roam at large
- h) Microchip all cats and kittens as soon as practical.

### 3.2 They WILL NOT

- a) Act, write or speak in a way that may be perceived as bullying, intimidation, abusive, discriminatory or derogatory
- b) Use any confidential information for their personal advantage or the advantage or disadvantage of any FCCWA member
- c) Use confidential information to disadvantage or discredit the FCCWA

# FCCWA Code of Conduct for all members

- d) Bring the FCCWA into disrepute by their actions, decisions or behaviour
- e) Speak or claim to speak or give the impression that they speak on behalf of the FCCWA or claim to be representing the FCCWA unless duly authorised by the Governing Council
- f) Sell or dispose of cats or kittens to or through pet shops or agents, markets or animal shelters, or allow any cat or kitten to be given as a prize or donation of any kind, nor act as an agent; for a third party in the sale or disposal of cats or kittens EXCEPT when participating in the rescue of cats or kittens.

## 4. Breeders Code of Ethics

All members who wish to be recognised as Registered Breeders must agree to uphold and respect this Code of Ethics in their actions and dealings within the Cat Fancy.

- 4.1 F.C.C.W.A. (Inc) Breeders shall maintain comprehensive records of all cats owned by them, all litters bred and the names and addresses of new owners of kittens sold by them.
- 4.2 The Breeder shall breed for the health, quality, temperament and the betterment of the breed. It is the responsibility of the Breeder to ensure that a prospective new owner who wishes to either breed or show the cat/kitten is provided with the best potential show or breeding cat/kitten available. Cats/kittens with breed faults or sub-standard animals SHOULD NOT be sold for breeding and showing.
- 4.3 Breeders shall maintain the best standard of health and care for their cats and keep only the number of cats which can properly be cared for and protected from illness and stress related problems.
- 4.4 Breeding cats shall be immunised regularly and tested against diseases
- 4.5 It is the responsibility of the Breeder to ensure that the animal will be given a permanent home and not passed on without due consideration for its welfare.
- 4.6 It is the responsibility of the Breeder to ensure, as far as possible, that the prospective new owner/s know how to care for the cat/kitten.
- 4.7 Breeders should make themselves available to novice Breeders or Owners for advice and guidance, especially those who have purchased cats/kittens from them.
- 4.8 No cat or kitten shall be sold to, or through, an Agent who in turn will sell them on to new Owners. (e.g. Pet Shops) Cats and kittens may be offered for sale at a Show but must not be sold and removed from the Show by new owners. All sales of cats and kittens should be conducted at the Registered Breeders premises. Any Members breeding and/or selling to the export market will have their membership revoked.
- 4.9 The Pedigree, Veterinary Immunisation Certificate and Certificate of Registration are the birthright of the cat or kitten and are not to be withheld for extra payment. The price must include these whether the animal is sold for breeding, showing, or as a pet.
- 4.10 Transfer of ownership of the cat/kitten must be effected within 30 days of the gift or sale to a new Owner.
- 4.11 Transfer may be made for "Breeding" or "Non-Breeding". "Non-Breeding" means that should the cat produce kittens, none of the progeny can be registered. The kitten is to be desexed. It is the responsibility of the Breeder to explain to the new owner the meaning of the "Non-Breeding" status. It is also important to point out to the new owner that, by signing the transfer application form, they are signing a contract to have the cat/kitten desexed.

## FCCWA Code of Conduct for all members

- 4.12 Matings: Agreements between the parties should be made regarding the costs and re-mating if applicable. The owner of the queen should make these arrangements well in advance and forewarn the owner of the stud of the impending visit of the queen. It is the responsibility of the stud's owner to witness at least three matings during the time that the queen is at stud. The stud service fee is payable and the completed certificate of service is to be provided at the time of service unless other terms have been agreed between the two parties.
- 4.13 The owner of a stud male will not accept unregistered females for service and will ensure that the female is owned and registered in the name of a financial member of a recognised registering Body.
- 4.14 Owners of queens will not use unregistered males for service and will ensure that the male is owned and registered in the name of a financial member of a recognised cat registering Body. Progeny of matings between unregistered animals or animals belonging to unregistered Breeders WILL NOT BE REGISTERED.
- 4.15 All kittens of a litter must be registered with the Feline Control Council of W.A. (Inc)
- 4.16 The cat/kitten should be in the best possible health and condition before it goes to a new home.
- 4.17 As far as possible it should be free from internal and external parasites, e.g. ear mites, fleas and intestinal worms.
- 4.18 No kitten should be sold until at least 10/12 weeks of age and the Breeder must ensure that the kitten is of sufficient maturity to cope with the move to a new home.
- 4.19 All cats/kittens should be immunised against Feline Infectious Enteritis, Feline Rhinotracheitis and Feline Calicivirus (Fe3 Vaccination)

### 5 Breaches of the Code of Conduct

- 5.1 Disciplinary action in accordance with the Disciplinary Policy may be taken against any person who breaches this Code of Conduct.

## Cat Act 2011 Update

### Cat Regulations 2012

In December 2012 the Minister's Office released a set of regulations in support of the Cat Act 2011. Excluded from the regulations are a fee structure and the issue of the number of cats that Councils will allow members of registering organisations to keep.

The good news is that FCCWA has been recognised as prescribed organisation for the purposes of clause 37(5). This means that a breeder who is a member of FCCWA cannot be refused a permit to breed by their local Council. The Minister's Office has recognised that members of registering organisations are governed by a set of rules and ethical guidelines. However, with this approval comes a responsibility to all breeders to continue to do the right thing, demonstrating that registered breeders are a special class and deserve to be recognised as having more controls and better breeding programs than people who are breeding on an uncontrolled and ad-hoc basis.

The issue of fees and the numbers of cats allowable to members of FCCWA is still being considered by the Minister for Local Government's Office and additional regulations are being drawn up. However, with the impending election, the WA State Parliament is now in caretaker mode and no new regulations can be gazetted during this period. However, we have been reassured that the Minister's Office will continue to work on the regulations with an expectation that they will be progressed after the election.

FCCWA will continue to advocate for the recognition of our breeders and show enthusiasts with de-sexed cats. If any new information comes to hand we will provide updates on the news page of the FCCWA website, the show page on Facebook and in the next edition of Cat Call.

In the meantime, if you have any concerns or are aware of any issues that relate to the administration of the Cat Act 2011, please do not hesitate to contact members of your Governing Council.

Some of the features of the Cat Bill that will directly impact FCCWA members were listed in the previous Cat Calls, but it is worth just highlighting some of them again:

- All cats over the age of 6 months must be registered with the Local Government in the area that they live.
- All cats must wear registration tags in a public place unless they belong to a class of cats who are exempt.
- All cats over the age of 6 months old must be microchipped
- All cats over the age of 6 months old must be sterilised unless they are exempt. A cat that is kept for the purposes of breeding is exempt
- A person is not permitted to transfer ownership of a cat that is not sterilised unless the purchaser is an approved breeder. The cat must also be microchipped. If the cat is less than 6 months old, it may be transferred unsterilised provided that a voucher for sterilisation is part of the transfer.

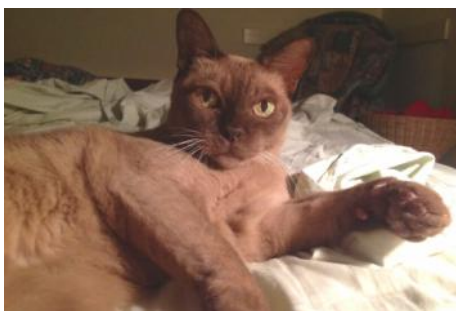
